# WEBSITE TERMS AND CONDITIONS OF USE

### 1. About the Website

1. 1. Welcome to www.blueboots.com.au (the 'Website'). The Website Educational programs and online tutoring services (the 'Services').

1. 2. The Website is operated by blue boots education PTY. LTD. (ACN 167 036). Access to and use of the Website, or any of its associated Products or Services, is provided by blue boots education. Please read these terms and conditions (the 'Terms') carefully. By using, browsing and/ or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.

1. 3. blue boots education reserves the right to review and change any of the Terms by updating this page at its sole discretion. When blue boots education updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

#### 2. Acceptance of the Terms

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by blue boots education in the user interface.

#### 3. Registration to use the Services

3. 1. In order to access the Services, you must first register for an account through the Website (the 'Account').

3. 2. As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:

- (a) Email address
- (b) Preferred username
- (c) Mailing address
- (d) Telephone number
- (e) Password

3. 3. You warrant that any information you give to blue boots education in the course of completing the registration process will always be accurate, correct and up to date.

3. 4. Once you have completed the registration process, you will be a registered member of the Website ('Member') and agree to be bound by the Terms.

- 3. 5. You may not use the Services and may not accept the Terms if:
- (a) you are not of legal age to form a binding contract with blue boots education; or

- 4. Your obligations as a Member
- 4. 1. As a Member, you agree to comply with the following:

7. 2. All trademarks, service marks and trade names are owned, registered and/or licensed by blue boots education, who grants to you a worldwide, non-exclusive, royalty-free, revocable license whilst you are a Member to:

(a) use the Website pursuant to the Terms;

(b) copy and store the Website and the material contained in the Website in your device's cache memory; and

(c) print pages from the Website for your own personal and non-commercial use.

blue boots education does not grant you any other rights whatsoever in relation to the Website or the Services. All other rights are expressly reserved by blue boots education.

7. 3. blue boots education retains all rights, title and interest in and to the Website and all related Services. Nothing you do on or in relation to the Website will transfer any:

(a) business name, trading name, domain name, trade mark, industrial design, patent, registered design or copyright, or

(b) a right to use or exploit a business name, trading name, domain name, trade mark or industrial design, or

(c) a thing, system or process that is the subject of a patent, registered design or copyright (or an adaptation or modification of such a thing, system or process), to you.

7. 4. You may not, without the prior written permission of blue boots education and the permission of any other relevant rights owners: broadcast, republish, up- load to a third party, transmit, post, distribute, show or play in public, adapt or change in any way the Services or third party Services for any purpose, unless otherwise provided by these Terms. This prohibition does not extend to materials on the Website, which are freely available for re-use or are in the public domain.

9. 2. Subject to this clause, and to the extent permitted by law:

(a) all terms, guarantees, warranties, representations or conditions which are not expressly stated in the Terms are excluded; and

(b) blue boots education will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.

10. 1. # 11. Limitation of liability

11. 2. You expressly understand and agree that blue boots education, its affiliates, employees, agents, contributors and licensors shall not be liable to you for any direct, indirect, incidental, special consequential or exemplary damages which may be incurred by you, however caused and under any theory of liability. 12. Termination of Contract

12. 1. The Terms will continue to apply until terminated by either you or by blue boots education as set out below.

12. 2. If you want to terminate the Terms, you may do so by:

(b) closing your accounts for all of the services which you use, where blue boots education has made this option available to you.

12. 3. blue boots education may at any time, terminate the Terms with you if:

(a) you have breached any provision of the Terms or intend to breach any provision;

(b) blue boots education is required to do so by law;

(c) the provision of the Services to you by blue boots education is, in the opinion of blue boots education, no longer commercially viable.

12. 4. Subject to local applicable laws, blue boots education reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Website or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts blue boots education's name or reputation or violates the rights of those of another party.

13. Indemnity

13. 1. You agree to indemnify blue boots education, its affiliates, employees, agents, contributors, third party content providers and licensors from and against:

(a) all actions, suits, claims, demands, liabilities, costs, expenses, loss and damage (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with Your Content;

- 15. Dispute Resolution
- 15. 1. Compulsory:

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

15. 2. Notice:

A party to the Terms claiming a dispute ('Dispute') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

15. 3. Resolution:

On receipt of that notice ('Notice') by that other party, the parties to the Terms ('Parties') must:

(a) Within 14 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;

(b) If for any reason whatsoever, 14 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the President of the Australian Disputes Centre or his or her nominee;

(c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;

- (d) The mediation will be held in Sydney, Australia.
- 15. 4. Confidential:

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

15. 5. Termination of Mediation:

If 2 Weeks have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

#### 16. Venue and Jurisdiction

The Services offered by blue boots education is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of New South Wales, Australia.

### 17. Governing Law

The Terms are governed by the laws of New South Wales, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of New South Wales, Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

#### 18. Independent Legal Advice

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

#### 19. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
